4. Course contents		
1.	Brief description of the course and its content including details of any sub-divisions	<i>The political development of the period from the first World War until contemporary times is discussed against the background of the history of the region, from pre-Islamic times until the 1990s. In addition to the development of the individual states, regional conflicts, in particular the Israeli – Palestine conflict, international relations and the role of religion in politics are analysed.</i>

		<i>Among social aspects examined are the economic development of the region, population growth, urbanisation, the labour market and its problems. Other important subjects include class, ethnicity, minorities, and the role of women. A short introduction to the early and modern literature of the Middle East is included on the course.</i>

5.	Teaching and Assessment	
1.	Teaching methods employed including details of any compulsory components	<i>The course is offered entirely as a distance course and makes use of interactive information technology. It presupposes that students who enrol on the course understand these conditions and have access to a computer with internet connections. Further information is available from the department regarding technical requirements. The course is built mainly on written communication. An important aspect of the course involves the students in reading, discussing and commenting on the texts produced by the other course participants. Students also have the opportunity to communicate individually with the course lecturer. Teaching consists of introductory lectures with study assignments and work assignments which are to be submitted. Seminar exercises in the form of group discussions are obligatory.</i>
2.	Examination details	<i>Examination takes the form of continuous assessment and is based on the results obtained on executed and submitted assignments, as well as active participation in group discussions.</i>
